

THIS DEED OF CORRECTION is made and entered into this 17th day of August, 2004, by and between PYXIS RESOURCES COMPANY, a Virginia corporation, CLINCHFIELD COAL COMPANY, a Virginia corporation, PARAMONT COAL CORPORATION, a Delaware corporation, hereinafter collectively referred to as Grantors, and HEARTWOOD FORESTLAND FUND IV, L.P., a North Carolina limited partnership, whose address is c/o The Forestland Group, LLC, 1512 East Franklin Street, Suite 104, Chapel Hill, NC 27514, hereinafter referred to as Grantee.

WHEREAS, by deed dated January 29, 2004, of record in the Circuit Court Clerk's Office of Dickenson County, Virginia, in Deed Book 396, Page 127 (the "Deed"), the Grantors conveyed to Grantee certain tracts of surface, timber, gravel and building stone located in Dickenson County, Virginia.

WHEREAS, specific property descriptions for additional tracts which were conveyed by Grantor to Grantee are now known, and the parties wish to include said descriptions in the Deed.

WITNESSETH:

NOW, THEREFORE, for and in consideration of the recitals sets forth above and other valuable consideration, receipt of which is hereby acknowledged, the parties do hereby include the following specific property descriptions in the Deed:

Tract 627 (Alex Sykes 34.57 acres - Haysi SW)

seventy-seven degrees one minute east (N 77 1 E) two hundred eighty-nine and two tenths (289.2) feet to a stake in the edge of river, thence south eighty-two degrees thirty two minutes east (S 82 32 E) two hundred seventy-six and seven tenths (276.7) feet to a stake in the edge of river, thence south seventy-two degrees forty-four minutes east (S 72 44 E) one hundred fifty-two and seven tenths (152.7) feet to a stake in edge of river, thence north eighty degrees sixteen minutes east (N 80 16 E) two hundred twelve and six tenths (212.6) feet to a stake in edge of river, thence north thirty-eight degrees fifty-seven minutes east (N 38 57 E) one hundred forty-two and seven tenths (142.7) feet to a stake in edge of river, thence north three degrees forty-one minutes west (N 3 41 W) three hundred six and seven tenths (306.7) feet to a stake in edge of river, thence north ten degrees fifteen minutes west (N 10 15 W) two hundred ninety-nine and eight tenths (299.8) feet to a stake in edge of river, thence north twenty-five degrees forty-eight minutes east (N 25 48 E) one hundred forty-five and three tenths (145.3) feet to a stake in edge of river by a root of birch stump, a corner to J.A.
