The species composition requirement is met for the Northern Atlantic Coastal Plain Swamp Hardwood &amp; Cypress AA, as loblolly pine (<i>Pinus taeda</i>) accounts for 36% of relative basal area (below the 60% SDI). In the Northern Atlantic Coastal Plain Southern Pine AA, loblolly pine represents 79% of relative basal area, exceeding the 70% SDI. The species composition requirement in this AA will be achieved in the first 25 years of the project by reducing basal area of loblolly pine via thinning. Management actions should reduce relative basal area of loblolly pine from 79% (2018 estimate) to 70% by year 2040 in this AA. This involves: (1) thinning loblolly pine in the Mixed Forest with Pine stratum to maintain basal area at or below 38.8 ft<sup>2</sup>/acre over years 11 to 25, and (2) thinning loblolly pine in the Mature Pine stratum to maintain basal area at or below 55.8 ft<sup>2</sup>/acre over years 11 to 25. This conservatively assumes that basal area of other species remains constant over the timeframe. The project is already progressing towards meeting the Protocol requirement via natural forest stand dynamics.</p>
